



**Pledge Agreement**

This Pledge Agreement is entered into by and between the individual(s) or entity whose name(s) appears below (“Donor”) and Leadership Nebraska City (“LNC”), an account of the Nebraska City Community Foundation Fund (“NCCFF”), an affiliated fund of the Nebraska Community Foundation.

LNC has received a challenge grant from NCCFF, an affiliated fund of the Nebraska Community Foundation. If LNC raises \$10,000, NCCFF agrees to match \$5,000. There will be no match unless LNC raises at least \$10,000. Once that minimum goal is met, NCCFF agrees to match \$500 for each \$1,000 additional funds raised by LNC, for a total maximum match of \$10,000 if \$20,000 is raised by LNC, resulting in a total amount of \$30,000.

This pledge is entered into in order to establish the level of financial commitment that the Donor shall provide to LNC and in order to establish the actions which LNC shall take in reliance thereon.
